General Terms and Conditions

1. The applicant should be a Citizen of India.
2. He/she should be of good character.
3. Upper Age limit: 38 years (as on the date of notification) is inclusive of the relaxation as per Government norms for OBC candidates.
4. Qualification of experience should be one acquired by the candidate as on the last date of receipt of application.
5. The experience shall be one acquired by the candidate on temporary or regular appointments in Central or State Government services or autonomous research organizations established or controlled by the State or Central Government. The experience gained on daily wages will not be accepted.
6. All applications received will be screened by a Screening Committee in terms of the criteria fixed by it and only shortlisted candidates after screening by the Screening Committee alone will be called for interview. The decision of the screening committee shall be final and binding on the candidates.
7. The Director KSCSTE-ICCS reserves the right to fill or not fill the post and that merely for the reason of making an application or inclusion in the ranked list will not give any right to the candidates for appointment to the post.
8. Eligible candidates may apply online through the application portal links provided in the websites www.iccs.res.in, www.kscste.kerala.gov.in, www.recruit.kscste.kerala.gov.in.
9. **Only online applications will be entertained**, under no circumstances any other mode of application will be accepted.
10. All candidates who are currently employed must submit a scanned copy of the NOC issued by the current employer. **Regular Government servants (Only)** who are not able to produce the NOC before the last date of online application, must submit the online application, and their NOC may be forward as hard copy along with their application through proper channel to ICCS (**Address: Director, Institute for Climate Change Studies, Deepthi Nagar Road, Muttambalam P.O., Kanjikuzhy, Kottayam – 686004**). If the application through proper

channel is not received before the convening of the Screening Committee, their applications will be summarily rejected.

11. The post is reserved to candidates belonging to Ezhava/Thiyya/Billava category (***applications from candidates of any other communities will not be entertained***).
12. Claims made subsequent to the application will not be considered under any circumstances. Proof submitted without proper claim in the application also will not be considered.
13. Applicants will not be granted opportunity to correct or rectify any mistake in the application. The original certificates to prove the age, qualifications, experience etc. shall be furnished as and when called for by the competent authority.
14. The experience certificate should be certificated by the controlling authority/Head of Office, where the applicant has gained the experience. Genuineness of the certificate shall be subject to verification and that if the certificate is found to be bogus, actions including legal action will be initiated.
